He quickly discovered that the district could benefit immediately from the efficiency of a validation tool. Two important areas stood out: discipline reporting and food service tracking. With Assistant Principals wearing so many hats, they hardly had the time to sit down and focus on discipline reporting. Also, the food service departments received thousands of account sign-ups. Aggregating and verifying the lunch status had become laborious and, in some cases, overwhelming.
